Resident of Rancocas: denies use of sheds on property

Resident Burlington Ave.: Against the ordinance as written. Existing ordinance on the books and have been for year. Follow through with enforcement through summons and fines.

Fitzpatrick: discussion on this in coming months. Asked for resident input for concerns and ideas.

Resident of West Ave.: Question on trailers. Can't park on the street. Where to park? Trailers are registered by the state.

Resident of Union: Town needs more ordinances like this; cites properties with uncut grass, deteriorating properties.

Fitzpatrick: Grass cutting - 1 warning, and a fine on 2nd offense.

Fitzpatrick: Residents have been offered to purchase adjacent properties. A letter was sent by the Township to people owning land adjacent to that strip of subdivided lots inquiring if they would be interested in purchasing those lots adjoining theirs.

4. Leaf pick-up starts soon

Code Enforcement Goffredo:

1. 29 complaints - 5 court summons/ 24 follow ups in compliance.

2. Problem with political signs; large size and too close to curbs.

Fitzpatrick: What's the status of Rahenkamp's land at Newton's Landing?

Goffredo: He's supposed to seed that area.

Corcoran: Area was seeded. It's a construction site. If seeds work, it should look better. State has changed laws to allow a developer to be under construction for 10-15 years.
