MEETING OPEN TO THE PUBLIC

Resident of Charles Circle: Fire hydrant – Newtons Landing is paying the water company and the fire department for the same service. When the planning board and developer set up NL, it is in effect a gated community. As set up, the association would be responsible for everything. Why are we paying the water company and then the fire tax for the same thing?

Jass: Not familiar with the HOA documents. I know that it's a gated community. I have to refer to our solicitor.

Heinold: Fire district is responsible for hydrants, not the township. Because The Point is private, those hydrants are on private land. We collect the fire tax, but don't control it.

Templeton: Fire is a separate taxing authority.

Resident: I don't understand why we pay twice. Since we are private, we are responsible for our own streets and curbs.

Heinold: For maintainence.

Resident: Shouldn't we get a tax credit?

Heinold: No, because it's private property. That's the way it was set up.

Resident: Can we do away with the community?

Heinold: I can't advise on that.

Jass: Tues, 24th at 7:30 is the fire meeting.

Resident of Second Street: Good point about hydrants. They are in easements to NJ American. Update on restaurant. Up for lease. If we don't get a tenant, we will have to convert to COAH residence. Thanks to Kate and Joan for giving them as much business as you did. We put in seven years and they have been brutal. Hinkle: Susan even went to the train station and gave out flyers. Fitzpatrick: Baccio's closed in Cinnaminson. Economy is like that right now. Resident: Spoke with vendors who did the linen services. They say the new restauants do well for 30-60 days and then they fall off. Many restaurants have closed. Madison isn't doing well either. Creekside – doing paving and on to maintenance bond.

MEETING CLOSED TO THE PUBLIC CORRESPONDENCE Lohr:

-Edward Stiple dropped a letter – appreciation for government services and public works department for excellent maintenance.

DISCUSSION ITEMS:

1. UPDATE: FIELD OF DREAMS PROJECT PHASE II (Field House) PHASE III (Continuation of Fields)

Denton: I will prepare a memo outlining where we are and what Rec has decided. Restroom, water and sewer service. Trying to establish rational for fair share... needs a higher level meeting. Building is the one recommended by Scott Taylor. Fitzpatrick: Presentation was done before Township Committee Denton: Punch list on Phase 1 almost done – waiting for Verizon to move their wires. Reseeding and fertilizing will be done in the spring. Fitzpatrick: My recall is that we weren't sure what grant money would cover. Township Committee agreed to pay balance if reasonable from Open Space fund. Iass: Should move forward with Phase III

2. PET-AID DROP-OFF

Fitzpatrick: Article in *Burlington County Times* for pet aid like a food bank for pets so families don't have to surrender their pets to a shelter. Delanco Municipal Building could have a box. Catholic Charities doesn't take pet food. I asked Peter Fritz to come tonight since he is familiar with the program.

Fritz (employee of American Red Cross): Program is part of Red Cross in Burlington County. My family also does foster family work. With the economy as it is, the shelters are overwhelmed with pets. Whatever we can do is a good thing. Program deals with feeding, but also preparation if there is an emergency with your pets. We work with CART program and Office of Emergency Management. Not just dogs and pets – equestrian program, birds, hamsters, etc. Red Cross learned through Katrina that people won't leave their pets so it is helpful to have parallel services to care for pets. They offer low cost chipping services as well. Last few

years, the Red Cross has done a holiday pet food drive – food, blankets, toys.

Jass: Are there programs for veterinary?

Fritz: Not sure. This program also leads to an awareness of all we do for veterans and blood drives...

Fitzpatrick: Township could do chipping here which would allow residents to get their pets chipped at a very reasonable cost.

Fritz: I would deliver the food as the local liaison.

Jass: Update on grants?

Lord: submitted sidewalks, Safe Routes and equipment for Pennington. Streetscape

is for Transit.

Fitzpatrick: Through the county
