1. Police

-Handicapped parking for 304 Burlington Ave. request – nearest place is 307 Burlington Ave., which was previously designated as handicapped for a prior resident. Recommend that handicapped parking be placed there.

2.Public Works

-5 passes for leaf collection – one of the only towns that got them all up due to the loader.

-Plowed and salted 4 snowfalls. – 30 tons salt – started plowing Rivers Edge. New signs made it better. Getting used to doing it and will continue to improve.

-Potholes – let me know – put out a ton already

Minor repairs done to snow plow equipment – hasn't been used for three years.
Everything is up and running. Had to replace cutting edge on front end loader \$1700 – saves \$14-15,000 down the line

Dillenbeck: -Attended fire commissioners meeting -Attended Bristol incinerator meeting in Burlington City – Florio is lead attorney. Something that we should be well aware of. Spurred to this meeting by Marlene Jass and Mr. Taraschi. Informative. Met mayors from other towns. Covered by Fox News. We don't want that incinerator in Bristol – bad for our health. Dr. Conaway made a speech about respiratory distress.

-Went to Rec meeting. 15 year old wants to start a summer theater program. Good sign when youth wants to get involved.

Fitzpatrick: Meeting in Bristol – were any of those people attending the meeting tonight?

Dillenbeck: (missed this)

Fitzpatrick: I understood they were going in for a variance.

Dillenbeck: According to Florio, this is a shell company that intend to store materials onsite until they get the permit to burn which may take two years. Transporting by truck, including medical waste Similar situation years ago near Burlington Center. Transportation of the toxic materials was the issue. Right now West Virginians can't use their water due to a chemical spill. Something that we don't want. There is a toxic incinerator in PA in a desolate area. You have to look for an area like that to build this type of thing.

MEETING OPEN TO THE PUBLIC FOR COMMENTS AND QUESTIONS SESSION ONE -

Resident of Pennington Court: Appreciative that you could attend the meeting about the incinerator. Tonight, Mrs. Jass let me read report from Burlington County Times from Saturday – apparently; this situation has been known to the county for at least a month. Resident read last sentence which listed towns in opposition. Asked committee to consider a resolution against the incinerator.

Jass: Last year, we had agreed to send a letter of support.

Fitzpatrick: Received an email from Linda Dougherty – asking Delanco to join – open-ended in terms of cost of counsel. We weren't in the position of committing open-ended legal fees at that time. We haven't received info regarding Florio. We didn't know if the variance would even pass.

Jass: Thought we agreed on a letter

Fitzpatrick: We didn't agree to do anything.

COMMENT AND QUESTION SECTION OF THE MEETING CLOSED TO THE PUBLIC

DISCUSSION ITEMS:

1. REQUEST TO SUPPORT 2014 GIRLS STATE PROGRAM \$2015 to sponsor a girl for this program. Didn't receive a letter for boys' state.

Fitzpatrick: Did support last year. Last year's recipient is coming to the Women's Club meeting to discuss her experience.

Ciancio: Is the girl selected from Delanco?

Fitzpatrick: Yes. Passed with Ciancio voting no.

2. Proposed ordinance vacating Commerce Drive upon conditions and authorizing execution of deed

Heinold: Costume Gallery was directed to resolve legal statues of Commerce Drive. Jevic controlled it for a long period of time and had asked governing body to have Commerce Drive dedicated to township and then asked for it to be under their control and to be private. Township didn't accept the road. Costume Gallery felt that action was insufficient and township should maintain it going forward. Reached out to John who responded that we don't plow there. This ordinance conveys the deed to Commerce Drive to that property and puts the issue to bed. There are conditions associated with the transfer – they need to work out maintenance agreement with the new neighboring business.

Ordinance 2014-3 vacating Commerce Drive upon conditions and authorizing execution of deed – 1st reading by title only. Public Hearing Feb. 3.

Templeton: Will this be Costume Gallery's? Would that require an easement for whoever is on the other side of the road so they don't decide later that no one can pass?

Heinold: Yes, that is part of the conditions.

Ciancio: Is Costume Gallery aware?

Heinold: Yes. They contacted us. Kitty has been very helpful with old documents. Passed unanimously.

Jass: Was discussed at JLUB at the time.

Fitzpatrick:

-Berger family – as a result of the article in Burlington County Times – gifts from Roebling American Legion. Gift cards as well.

Ciancio:

-My no vote on sponsorship for Girls State 2014. They are asking for \$215. Why are we doing \$2015?

-Amended and the vote to passed unanimously.

Dillenbeck:

-Big winds – tree limb fell from township tree. Called John and they cut it up the next morning.

Presentation of a plaque to Kate Fitzpatrick for her service as mayor and for her service on town council.

Fitzpatrick: I asked specifically that this not be presented during reorganization because I wanted it to be Bill's night.
