-Verizon sent letter – follow-up on impact of Verizon's unilateral decision that it no longer provides service to 51% and they will no longer pay taxes based on the value of their equipment. \$10,500 impact in their taxes on our budget. Another township filed suit. Dial tone is provided through them, but not directly since some use a third-party that rents from Verizon therefore more than 51% actually use their lines. Currently under review by Appellate Division. Legislation is pending to clarify the law. Suggest that we vote to go on record to send a letter to support that legislation.

Fitzpatrick: We should do it now.

Motion Passed unanimously

- -Special officer is leaving for full-time job in Cinnaminson. They got him before we could get him. DeSanto is looking for a new special officer.
- -Received state best practice inventory. Need 41 questions at yes or not applicable or there is a reduction on state aid. Today we could get to 39 and will bring back to the meeting in October. May need to make some policy decisions to qualify. We have made changes in the past. They delete items and add new ones. There are always one or two.

Police:

-Handicapped parking 416 Ash. Didn't have enough time to evaluate completely. Want to look at it again at another time of day. Want to look at night. There is another one on the block.

Dillenbeck: Ash Street is packed.

Fitzpatrick: You want to look at it again?

DeSanto: Yes. Want to see if the other handicapped space is active.

Ciancio: How is the parking ordinance going?

DeSanto: Only 7 households responded. Additional one was the developer at the Columns. This weekend warnings were issued. If people aren't in compliance, we will issue tickets. Sent letter last week in August.

Fieri: Delanco EMS Chief - EMS is pursuing epi pens to help people having allergic reaction. Don't need a prescription.

-Learning new system since state switched contractors.

Templeton: How is your volunteer status?

Fieri: Good, but we can always use more people. Working on our night procedures. County has dispatch guidelines. Trying to shorten response times.
