Police slots are being filled as well as equipment and vehicles for them. Reduced Public Works personnel: Increased Shade Tree budget due to blights that will

Police slots are being filled as well as equipment and vehicles for them. Reduced Public Works personnel; Increased Shade Tree budget due to blights that will necessitate tree removals. Deferred cost for unsafe building removal last year to this year's budget. Governing body asked for increase in capital fund for deferred maintenance to deal with tree root/ sidewalk issues, public works equipment, maintenance of the municipal building, seawall repairs, and pole barn at public works. Fitzpatrick: Thanks to Richard Schwab for diligent work on budget and working with us. Makes our job much easier.

Dovey: Based on Edgewater Park council experience, Richard has done an excellent iob.

Passed unanimously.

DeSanto: Meeting tomorrow with towns involved. JIF had a recommendation. General liability is covered, but not workman's comp as volunteers are not in NJ. Opportunity to have resources available that we would not always have. Chaplain on call. Primarily for the police officers. Objective party if they are feeling stressed. Secondary role is community liaison. Chaplain will help notify families as needed and mitigate tension between police and community if it arises.

Schwab: If chaplain is injured due to negligence of the township, they are covered under general liability as are other community volunteers. Passed unanimously.

## **DISCUSSION ITEMS Session One:**

1. VERIZON REQUEST FOR RIGHT-OF-WAY FOR NODE INSTALLATION-PROPOSED RESOLUTION (Continued Discussion)

Fitzpatrick: Aren't we waiting for them to get back to us?

Schwab: Two issues - not connected. Wireless wants the nodes. Direct disagreement between them and the governing body. You want to give permission when they have a plan. Other communities I deal with - once they have the general consent it is hard to turn down locations. If you have any concern, just say no. The issue Jennifer Young was here about was separate - landline and DSL. She took phone numbers and will be looking into those issues. Obviously Verizon wants to get to wireless. They want a blanket consent. Lots of discussion in DC from FCC - a lot going on right now. My opinion is to be patient and let them chase you on wireless, and wait for Jennifer to get back to us.

Fitzpatrick: Yes, I'm not in the position to move forward on this.

Jass: Another town received a stipend of \$1000.

Schwab: They will pay costs for review. If Doug develops an agreement, we should bill them. If they are at the point of installing, they should pay for engineering like any developer. They want this open-ended consent.

Dovey: I'm against consent. They haven't addressed safety or other issues.

Templeton: We have suggested that they do the survey - no consent required for that. They should come back with their results. The handout you passed on showing different installation options... if a pole has too many items, it is suggested that they sink another pole. Maybe we are looking at more telephone poles. That's something to consider.

Jass: They put in a support and you don't know how big it is.

Browne: We will hold off.

Schwab: Until we hear from them.

# MEETING OPEN TO THE PUBLIC FOR COMMENTS AND QUESTIONS - SESSION ONE

NJ Residents Against Puppy Mills representative: Asking for introduction and passage of ordinance to restrict purchase of puppies and kittens from mills. With an ordinance in place, no store that does this will try to open here. Five towns around the state had legal, police, and health costs engendered by trying to shut down pet stores. Ordinance would only allow sale of dogs from shelters or 501c3. Mills are commercial entities with terrible treatment. Pets have emotional problems.

Fitzpatrick: Just closed a store in Burlington County.

Representative: Springfield - That store has had one problem after another. They weren't complying with state laws. Breakout of Parva. They could open in another town. Besides helping puppy mill dogs, you would be protecting consumers. New pet owner in Brick bought a dog that was sick and spent thousands. Our taxes pay for the Burlington County shelter. Many shelters bring up dogs from the South. It doesn't deny a person from having a choice. Has no impact on buying from a breeder. Haddonfield just passed an ordinance - 100% in Camden County. NJ leads the nation.

Fitzpatrick: I read the emails. You are right. We didn't do it sooner because we didn't have a store. I would be in favor or the ordinance.

Browne: We can put in on for discussion. You are regulating a store on what they can sell. Chances are rescue dogs are mixed breeds. I don't think we belong in that business.

Fitzpatrick: Let's put it on for discussion for April 17.

Browne: We have enough trouble getting any business in Delanco. A lot of Amish are the breeders. If you are getting into this, if you go to a pet store, they don't belong there. If we get into the business of private industry, ...

Representative: This is a humane issue.

Browne: You are talking to a mayor who doesn't eat meat because I don't like how the animals are treated. People are educated.

Representative: No, they are not. I go in every store in the state. When I ask for a breeder sheet, health records, they ask me to leave. They don't want to tell you that information. The store in Brick was mobbed on Saturday and they just sold a puppy with Parva.

Browne: Was a victim myself. Gave a cat I purchased IVs, sued.

Representative: Then I am surprised you aren't for it.

Fitzpatrick: I would like to discuss it. Do you feel you need to be here, John?

Browne: Government doesn't have the right to tell a merchant what product they can sell.

Jass:

Representative: The stores source from puppy mills.

Jass: If I wanted to breed here, I could sell my animals.

Representative: If you sell more than 10 puppies a year, have to send a list to the state. Browne: We had a breeder in town. If someone were to open a store, she couldn't sell an overflow through them.

Representative: Needs a USDA license. Rare that someone has this. This only applies to pet stores. Three stores have gone humane model - puppies from the South. Sell for \$500 to cover spay/ neuter. Saving a life. End goal is to close the puppy mills.

Fitzpatrick: I know what's going on there.

Jass: Can the emails be recirculated?

Representative: I can email and I have a sample ordinance.

Lohr: April 17 - start the discussion

Fitzpatrick: Can you remove the approval of minutes? I've been sick all week and haven't had a chance to read them.

Browne: Yes

# **DISCUSSION ITEMS** Session Two:

1. COMPLETE STREETS POLICY – PROPOSAL FOR ENGINEERING SERVICES Schwab: Received proposal as follow up to prior discussion. Would give us higher point score when we apply for road work grants. \$4750 + planning costs from Taylor Design.

Fox: State adopted policy in 2009 encouraging town or developer to consider entire roadway when they do work - sidewalk, bike lanes, handicapped ramps, bus stops, etc. You get more points on DOT grant applications if you have a policy. 6 municipalities in Burlington and many in Camden County have them..

Fitzpatrick: We asked the cost because we wanted to have it done.

Jass: Seminars and meetings stress that you need the points to get the work done. Fitzpatrick: We asked Chris to do this for us. Whether we get a grant or do it on our own, it allows us... it's important to move forward with this.

Browne: Why the proposal from Taylor Design for existing streets?

Fox: It's an amendment to the master plan. Includes long range plans. What this is a 6-7 page document that states where there is a bike lane, (ex). Complete Streets Committee is required to review and make recommendations.

Jass: It's in state best practices.

Schwab: Not yet.

Jass: Have to spend money to get money.

Schwab: Increase in gas tax, doubt DOT will actually make a requirement as opposed

to giving you an advantage.

Templeton: When you have this and apply for grant, does it require you to do all of those things?

Fox: No, there are exemptions. You can set that yourself - more than a certain percent of total project, you don't have to do it. You set the percent.

Templeton: If you receive the certification, you can just fix a street, you don't have to buy the whole fixed price meal.

Fox: Yes.

Templeton: Who is the subcommittee?

Fox: Appointed by TC.

Templeton: Makes you buy more than you need. They keep coming up with these things - lots of hoops. Spending hard-earned tax dollars to get into the pool.

Jass: Cooper Street - how long have we been trying?

Templeton: This isn't going to change it.

Jass: Gives us the opportunity to look for money. If we don't do this, we won't be able to compete. \$4700 + amendment to master plan. JLUB needs amendments anyway. Opportunity to supplement what we an afford or we can plod along and hope for the money.

Fitzpatrick: Is JLUB aware of this? Jass: No, but this can be added in.

Martin: JLUB needs complete review of master plan in a year.

Templeton: Paragraph 1 - all that language is already in the master plan. We spend \$30,000 every couple of years to say the same words again.

Jass: You are right. Government is like that.

Templeton: Does this bind us to a whole package is the question? I think Mr. Fox addressed that.

Browne: Not sold on it. Don't see what we are getting for it.

Jass: When we go for grants, we spend money on the engineer. We get turned down every year. We are spending money for that too.

Browne: Don't we have an application for RiversEdge and Fenimore? Approved? Fitzpatrick: Yes. No.

Fox: That one is pretty much guaranteed.

Browne: Paper reported today - we weren't one of the recipient.

Schwab: This has no affect on Safe Streets for pedestrians.

Browne: We have money in budget for capital and are going to start fixing stuff.

Jass: Many streets need to be milled down. Looking at a large amount of money for most of the streets in our town. When we get the grants, we only get part of it. A street runs about?

Fox: 2 blocks for \$150,000 - curbs and aprons.

Fitzpatrick: Will this help us be more competitive?

Fox: Gives extra points. If you are tied with another town that doesn't have it, you would get it.

Jass: It's a crap shoot.

Fitzpatrick: i would roll the dice.

Fox: Could put it off until next year when they are doing the master plan. We would do

it on our own and give it to them to be sure it matched the master plan.

Fitzpatrick: It doesn't need to be done in conjunction with their changes. Are they

making changes for this?

Fox: They might.

Jass: Move that we authorize complete streets policy.

Templeton: As outlined in March proposal.

Passed with Browne voting no.

# 2. REPORT ON MEETING WITH NJ TRANSIT AND WALTERS GROUP FOR PEDESTRIAN ACCESS EASEMENT AT LIGHT RAIL STATION PROPERTY

Browne: Question about work permits, construction easements regarding sidewalk access to rail. Worked out well. Two questions:

1. Iron Flange Man has to go.

Browne: Could ask Mr. Rhawn if he wants one.

Jass: Historic Preservation asked for both of them.

Browne: I will ask and find out what's going on.

2. The other question is that Rhawn Street is an easement that NJ Transit will plow for snow. They are worried that residents won't be plowed out until the second day if there was a state of emergency. They would like us to plow Rhawn Street.

Fenimore: (missed it.)

Templeton: Supposed to be an entrance to a proposed residential development.

Jass: Main entrance is off of Cooper Street.

Fitzpatrick: Who does sidewalks on Pennsylvania Avenue?

Martin: NJ Transit said they have a contractor. I told them they aren't getting their money's worth.

Fenimore: They push the snow right to the lumber yard.

Jass: If you plow the easement and plow them in...

Fenimore: When we plow, snow has to get pushed somewhere.

Templeton: Who are we plowing the street for?

(not sure who answered): the residents.

Are they plowing the parking lot at Cornerstone?

Fenimore: They are.

Templeton: They should do the street. They need to get to the parking lot.

Jass: Because it is an easement into Cornerstone, responsibility lies with them. I don't think we should make any commitment.

Fitzpatrick: Whose easement is it?

Jass: Belongs to NJ Transit. Cornerstone has easement. Who plows road back to

Silvas?

Fenimore: We do. They are residents. Fitzpatrick: These people will be too.

Templeton: Cornerstone should take care of it.

Jass: Nothing in writing now. They are working on expensive improvements that we aren't paying for.

Fitzpatrick: Not our problem right now.

Browne: We help each other out.

Fitzpatrick: Then plow it.

Fenimore: How are you going to stop plowing in the middle?

Jass: Cornerstone has a responsibility.

Templeton: They bought a landlocked property. Browne: Not landlocked. NJ Transit parking lot.

Lohr: In state of emergency, are they asking us to plow only when emergency is

suspended or all of the time?

Martin: All of the time.

Fitzpatrick: If Rivers Edge takes care of their entrances, they should to. Walters Group

should take care of it.

Dovey: John will be coming out Rhawn. He won't be stopping.

Fenimore: We are here to help people out.

Fox:

-Seawalls - got letter from mayor to submit for emergency seawalls for 3 street ends,

-West Avenue fields are completed. John has been a great help.

Fenimore: Hard to put new clay in an old clay field. Trying to blend it in. Starting to look good. Very nice job done there. Street to compost starting to disintegrate.

Fenimore: Asphalt needs an overlay.

Fox:

-Long-range program document - map, description of each road and condition. Will get that back to John and Richard.

Dovey: They work for us. They don't go out for reelection.

Browne: If the developer sold it with the tree, they have to provide the tree.

Dovey: I didn't buy my house due to the tree.

Jass: It is a legal issue.

Fitzpatrick: It's common sense. Let JLUB come here when Doug is here.

Browne: Need to look at our ordinances regarding what the sidewalk strip should be.

Jass: Any new development we could do that, but existing plans we can't.

Fitzpatrick: Nothing says this plan can't be amended. Plans are amended all of the time. Engineer is the ultimate one to sign off on it.

Fox: Developer doesn't care. Lots were sold showing a tree on the lot.

Fitzpatrick: He only sold three. I would just hold off of the trees. I would stand my ground on this.

Fox: When the developer wants to get off the performance bond, that's when we look at living trees and are they were they are supposed to be.

Jass: Need to hear the legal outcome.

Fitzpatrick: No trees until our next meeting.

Fox: Developer is ready to plant them.

Browne: On Walnut Street bonding issue, waiting for good weather. Current application. Which are we doing?

Fox: Doing both. Finishing ramps. You get a better price doing more ramps.

# Department Heads:
