Heinold: In preparation to transfer Rhawn tract to Cornerstone – closing next week – there are a number of documents to be executed. We had the ability to recapture if Walters didn't come through up to now. Wells Fargo needs recapture to expire as per their investments. There was a bank lien which is our affordable housing. Walters fronted \$500,000 to clear. Deed restrictions will be put in place so Walters will pay back Hovnanian. Block and lot issues will be cleared up. NJ Transit requires township be permittee for improvements with Walters paying for fees. Steve Walsh, our insurance, will get insurance certificate from contractor. Resident of Franklin: Is Walters Group affordable housing? Browne: Yes,

Heinold: Walters Group = Delanco Family Apartments = Cornerstone Jass: Commending committee for diligence put forth with this entity to dot all i's and t's. Solicitor too. I was impressed with the job we have all done on this document to fulfill obligation for the best for our town.

Heinold: Looking at what is happening with other towns, this was a good decision. Some towns are being directed by court to bond for affordable housing. That has an impact.

Jass: Jesse contributed also by investigating other projects by this developer. Fitzpatrick: Ditto what was said. Delanco was fortunate to work with Joe Delduca – one of the best professionals I've worked with. He has taken it with many obstacles in his way. Developer has done a great job working with Delanco. He is an attorney also. He took on a lot of responsibilities and obligations that weren't his. Resolution 2017-111 Passed

Templeton: Have been consistent with not voting for some of these projects. There is a concern that the township is guaranteeing the \$500,000 loan. I think the keyhole cut out of Hoynanian project and included with this one will be problematic

with subsequent development. Troubled that project is in flood plain – problem nationwide with low income housing being located in flood plains. Putting a lot of faith in Mr. Heinold and the work he has done here. Voting yes.

RESOLUTION 2017-112 AUTHORIZING MEMORANDUM OF UNDERSTANDING BETWEEN THE DELANCO TOWNSHIP POLICE DEPARTMENT AND OTHER PARTICIPATING MUNICIPAL POLICE DEPARTMENTS IN THE RIVERFRONT POLICE CHAPLAINS RESPONSE TEAM FOR POLICE CHAPLAIN SERVICES

DeSanto: Slight change to initial plan – county OBM has stepped away. We have met as a riverfront group three or four times. Burlington City is a leader in the state – secured training and instructors and will be free for us if we are part of that group. We would be able to pull a resource and get additional training for our chaplain at no cost. Insurance issues are the same as when county was involved. Burlington City is willing to take on an administrative role.

Browne: Pastor Chuck Mitchell?

DeSanto: Best practice is for each township to develop own ordinance since it will be sustained here. Reverend Mitchell has always expressed interest. Got donations to send him to initial training. First he would be our chaplain, then he would be a shared resource with other towns.

Passed unanimously

MEETING OPEN TO THE PUBLIC FOR COMMENTS AND QUESTIONS - SESSION ONE Resident of McCay: Thanks to Mike Templeton for making that resolution unanimous.

Liz Mataset representing Environmental Advisory Board:

- -Anti Idling Campaign formally requesting resolution be adopted.
- -Sent email to Mr. Fenimore to meet and go over locations.

DeSanto: State statute enforceable on public and private property. No ordinance needed to enforce. I would encourage education program. Seems heavy-handed Browne: I would be for passing the resolution to back up EAB and their grant. Fitzpatrick: Caught by the bridge several times and realized I was idling. Good place for a sign.

DeSanto: Yes.

Jass: Have a copy since last meeting. Mataset: Climate Summit coming up. Jass: Do you get points for attending?

Mataset: I don't think so.

Mataset: Rhawn tract. When I take the train and look at that beautiful field, I think it would be nice if it could stay a field. Seen lately how important buffers are around water. Would the council consider a conversation to preserve at least a part of it? I have talked with Trust for Public Land. They are good at bringing in developers who have already gotten approvals. I could forward a contact for Kathy (missed it.) It might be worth having a conversation.

Heinold: a significant part of waterfront has been preserved by county – first 500 feet as part of county stretch. From a legal standpoint, the horses have left the barn

and are out of the pasture. Affordable housing is a constitutional obligation for the town. That is pretty much set in stone. I hope you take some solace in the fact that there is a preserved part.

Mataset: Rest of the tract?

Fitzpatrick: Slated for senior housing.

Mataset: It has happened before the shovels hit the ground in the past. TPL would like Township Committee to be open to it.

Browne: If we could stop housing there, it would be a beautiful thing. We need to have the affordable housing. I don't think owners would sell. They have approvals to make money there.

Mataset: They could still make money if they were bought out at the right price.

Browne: Without the senior housing, ...

Fitzpatrick: By doing it the way we did, we had to build fifty fewer units.

Browne: Hawk Island – that would be a great place.

Fitzpatrick: That would be great to contact them. We would work hand in hand on that.

Jass: Workforce housing 63 units – in planning we ensured 103 seniors to support the affordable students.

Fitzpatrick: from 166 family units to 103 senior units.

Fitzpatrick: Would you look into having the Trust for Public Land contact the landowners?

Mataset: They are very good at drawing in partners. They are a national non-profit. I know them through my work at Green Acres. They were successful preserving 500 acres that was slated for over 1000 housing units.

Dovey: I would be interested in entertaining that since things haven't moved fast with developer- we are talking about the farm field – sure that people in Newtons Landing are in favor of preserving. Courts have a way of bending and twisting the current rules. That scares me.

Browne: Committee should look into Trust for Pubic Land or have Doug look at it. Maybe a subcommittee.

Fitzpatrick: Do they buy property?

Mataset: They don't hold property. I approached them. She said it would be a good piece to approve. If developer has approval, they want buy in from the town before they negotiate. They have worked with Hovnanian in the past.

Heinold: Worth discussing. We had two parcels slated for larger developments. Concern that if senior units don't get built, what does that mean for us from a fiscal point of view?

lass: I have lot and block of everyone on Hawk Island.

Fitzpatrick: Mike gave us that last week. I would love to work on that. I bet Mike would.

Mataset: Sometimes with multiple property owners, you get here and there and it takes a few years.

Fitzpatrick: If EAB takes that on, county was doing title searches to take over those properties.

Templeton: EAB can put some resources into it. What about the Idling Resolution? Browne: Would like to hold it to Sept. 25, but Mike wants to move it forward.

Templeton: We've done other resolutions in a meeting.

Fitzpatrick: She handed it to us at the last meeting.

Mataset: No timeframe for resolution. We didn't get certified this year. We did get

a grant and need to spend the money.
Browne: Next meeting for the resolution

#### DISCUSSION ITEMS - SESSION ONE

1. PROPOSED ORDINANCE "An Ordinance Creating the Position of Police Chaplain for the Delanco Township Police Department

Schwab: What is workman's comp situation? Burlco JIF was concerned about how that would be handled. If you are supportive of concept and the issue to be resolved is how to insure, we can finish and introduce at Sept. 25 meeting.

2. PROPOSED ORDINANCE "An Ordinance of the Town of Delanco Entitled "Rental Property" (Nuisance Issues)

Browne: Tightening up our policies. I shared Hammonton ordinance with the committee. Adding teeth to address property conduct. Discussed in executive a little bit.

Jass: Read the Hammonton ordinance and comments of our attorney, and think we should move forward. Need to let our landlords know we are concerned as to safety of tenants. We need them to be more diligent in screening applicants. Lot of room for discussion.

Fitzpatrick: I'm willing to move forward. Lots of complaints from residents in the district I live in.

Jass: Since I've been in town for 16 years, I've only heard about problem. We didn't want any more conversions.

Fitzpatrick: All those rentals were once lived in by homeowners who worked hard and maintained them. When they were sold, they made two units. It's disgusting to see what some of our side streets look like. Need to enforce property maintenance. Jass: There are homes that are rented that have the same problems.

Templeton: Longer term – we need a property tax incentive to try to encourage apartments being converted back to single. Try to convert from transient to homeownership.

Savings. They were interested in helping with that. I still have that file.

Browne: I will be the OpEd on this ordinance. Concerned that we are singling out rentals vs. homeowners. Hammonton's ordinance – three strikes and you are out -\$750 fine with eviction. You won't punish homeowners. I'm being cautious that people aren't discriminated because I rent. As far as converting rentals back to one unit, the math doesn't work to bring the rentals back. I could have done it. There is a market for half doubles. Young people need rentals. Lots of people rent since 2008. Not bad people. They don't want to own again – less maintenance. I've been in my house 20 years, I wouldn't make a dime.

Fitzpatrick: I have lived in my house for 20 years and made a lot of renovations to that shack

Jass: Our ordinance as it is now already has a fine in it. Jesse called Hammonton to see how the enforcement works. Makes the landlord more diligent in who they rent to

Browne: Having Jesse and Richard get together

Jass: People need incentives for conversions. PA does that.

**DISCUSSION ITEMS - SESSION TWO** 

DISCUSSION OF RESPONSIBILITY FOR MUNICIPAL PARK TREES AND MAINTENANCE

Dovey: Purpose to make all on TC be aware and have a chance to look through and see what you aren't comfortable with. Just saw another analysis of tree ordinances in NJ. Will email through Kitty. It explains the type of ordinances and best wording for them. Can involve private property too. If you have a diseased tree, Shade Tree could take care of to keep them from spreading.

Browne: May not go to private property.

Fitzpatrick: Thought you were going to put together something to present to us.

Browne: We are ready to go to Shade Tree for joint committee.

Fitzpatrick: Conversation about who has jurisdiction on trees in parks. Thought Rec and Shade Tree should work together with TC having the final say since all parks come here for final approval.

Dovey: That wording should be in the ordinance.

Fitzpatrick: Recreation didn't start Gateway Park – TC did it. We did it in phases and went forward with the plans and approved every plan. Shade Tree or Recreation should present their plan. We will have final approval. They are out of the loop of the final approval. That will eliminate any misunderstandings.

Browne: That would have to be in the code. Too many things that don't have an appeal process.

Heinold: Definition of commission is by statute.

Templeton: Both entities are consultants to this body.

Heinold: Could be decision by one of the two with advice and consent of other with final approval here.

Jass: Shade Tree – just for parks?

Templeton: Anywhere

Dovey: We have the liability and have to approve.

Templeton: If Shade Tree has a proposal, they can submit it in a monthly report. If it is within a park, recreation should be part of that. Submit a letter with

recommendation. Consensus with one proposal.

Dovey: Property owner may not want that tree there.

Browne: They handle removal requests without us.

Fitzpatrick: They are dangerous trees. John looks at them for us.

Jass: Are there going to be a lot of gray areas>

Dovey: Two ordinances – parks and shade tree – let's get that corrected.

Heinold: Suggest two things. Within parks, we can draft as we are discussing. Right of way is a second step. Might want to have conversations with Shade Tree before we take that step. If Shade Tree works properly, they should be able to deal with it as our designee. We will have tree work at every meeting.

Fitzpatrick: When they do plan a planting in right of way, homeowner is asking for a tree. That's how they have done it over the years.

Dovey: Consult with John. He may have a reason for not wanting a tree there.

Browne: Let's have Doug work on it. Bob and I are ready to go to Shade Tree.

Schwab: Sample ordinance you provided is based on having a certified tree person as code enforcement. We are less on plantings and more on removals. It does put all costs on homeowners. This is focused on plantings.

Jass: On JLUB, Shade Tree Commission had arborist come up with list of acceptable trees to be planted.

Schwab: In this ordinance, standards of small, medium, large. Town I used to work in had tree species listed, but they have certified arborists on their Shade Tree Commission

Dovey: Shade Tree does have a professional

Schwab: This one has an arborist as code enforcement. Would caution against adopting this particular ordinance.

Fitzpatrick: Do you want me to highlight what I like and give it to you?

Dovey: Yes.

Browne: Table til 25<sup>th</sup> for everyone to highlight. No rush.

Dovey: They don't think there is a problem.

Browne: Trying to think ahead 25 years. Shade Tree shuts down Nov, Dec.

Dovey: We had engineers and professionals review proposals from JLUB. No one questioned where they planted those trees or that wrong trees were planted. We got lucky with grant for Newtons Landing that we didn't get yet.

Jass: From JLUB, need to convey and communicate through engineer from JLUB that we don't want field changes. When Hovnanian brought this project forward, it was on my list to remind the engineer.

Dovey: Looking at the plans right now, same mistakes.

Jass: It was pointed out. Field changes.

Fox: For locations

Fitzpatrick: Markouts should be there. Love that these ordinances let me take out a tree if it affects my sidewalk as long as I replace from the list.

Browne: You will get kick back on that.

Let's move forward. Doug and Richard move forward as well.

-Started design for Newtons Landing sidewalks. 190 locations. Less sidewalk than estimated. Will be able to take care of sidewalk at the trees. No room to go around the trees due to utilities. Rubberized sidewalks are an option – may not be the best. Could cut roots. All the trees except for a couple are what was spec on the plans. 91 tulip poplars – will be 100 feet tall. 51 American ash. A lot of them look sick. 10 other diseased. They planted trees on top of inlets. One tree is breaking up the road. 61 trees that we recommend be removed.

Browne: Shade Tree is aware – can't take them all down at once.

Fox: Part of our application.

Browne: Tulips should be removed.

Fox: yes.

Browne: Policy is that the ash trees will be taken down – no arguments.

Fox: Will be close with the grant money we have. Need to throw in some extra trees that will need to come down as we go case by case. Doesn't include replacing trees.

Dovey: If irrigation systems run out to curb, they are illegal, right?

Fox: Technically. Some of the heads are right at the trees. We can cap at the

sidewalk. Might be an idea to send a letter.

Fitzpatrick: When we get the grant.

Fox:

-2018 Local Aid applications due Oct. 6.

Jass: Done. Picked streets that were started.

Fitzpatrick: Fenimore and RiversEdge

Fox: DOT is putting up more money, so we should apply for more – \$3-400,000.

Maps set what they see as 100 or 500 year flood map – how far above that do we require new construction? We decided on 2 feet. More than 50% value to rebuild will have to comply. Ordinance for next meeting. Sent to DEP advisor for review.

Jass: If you have a slab, how can you raise it?

Fox: If you are in a flood zone, have to raise on pilings.

Schwab: Trash collection contract – low bid is to continue with South Jersey.

Beverly, Edgewater and Delanco will be meeting with them towards a two year contract. Going over some things we haven't been happy with. Hopefully done in October.

Browne: Does he have to be Rice noticed?

Hienold: Yes.

Browne: He can do it in public or in executive.

Schwab: She was arrested last week.

Fitzpatrick: I'm taking pictures of properties.

Jass: What's wrong with bringing Ron in?

Browne: It's important to see heads once a quarter or year. Need to look at zoning officer. Tom Casey said all goes through him.

Schwab: Only when it goes to court. Ron has the authority on violation notices.

Once the complaint is filed, Tom signs off on it. We don't fine; a judge does.

Browne: Number one complaint is property maintenance issues.

Schwab: You can sign all the complaints for years, but until the judge issues a bench

warrant... When properties are abandoned, you can't get to a person.

Browne: We have culprits that are violating all the time.

Fitzpatrick: Why should we have to notice every time?

Schwab: It's the law. Usually if you send the notice and then they comply.

Browne: Why do we have to Rice notice Ron? We don't notice Jesse.

Heinold: It protects us.
