COMMENTS AND REPORTS Township Administrator

- Basins that were cut properties were billed. A few haven't paid and have had money added to their bill each week.
- -Met with PSE&G service representative on several issues. 1 holiday decorations towns have to be permitted to put them up. You need to let them know in November. The sooner the plans are made the better. You need resolutions and hold harmless clause by JIF as well. 2. PSE&G will be trimming trees
- 3. Solar. Solar people still aren't doing what they suggested they would provide i.e. solar for this building. Should still be room for us or others in the area on the circuits, but it is first come, first served. 4. Street lighting green induction not great. PSE&G is going to bring in LED bulbs in 2019. We will see what the lighting levels and costs will be. Explained to PSE&G that police won't be assigned to PSE&G projects in town unless the township is compensated as per ordinance.

# Department Heads:

#### Chief of Police

- -arrest was made on persons stealing packages. Resident was alert and able to give a great description which led to arrest.
- -Gift from Pearson School second grade class wrote letters to police department. Much appreciated.
- -University of Michigan sent a letter as did their chief of police regarding the university's Institute of Social Research. They do national research which is used to develop policies that affect public and private sectors. They have selected certain areas in Delanco for study. Background checks are done and ID is issued. No one is forced to participate. Their budget is \$91million a year.
- Had a controlled bleeding class. Good learning opportunity.
- -Attended RiverRoute meeting jughandle at 130 and Bridgeboro has been identified as a problem in the grant. Grant will be used to document that through engineering. State DOT decides where it falls.

Fitzpatrick: They chose Cinnaminson to do in the past.

DeSanto: They had a different study with a proposed way to solve the problem by pushing the jughandle up north.

- Also attended Route 130 meeting – asked about current and foreseeable problems. Jass: We identified all of the commercial growth.

DeSanto: There is lots coming that will impact on Coopertown Road.

Jass: We talked about sidewalks and lighting.

DeSanto: Majority of the meeting was us trying to get anything we could

-We are working with two companies in town that are causing traffic clogging and storing bulk material in the front of the building which is in violation of our code.
